01 Election of Chairman

The minutes were **agreed** as a true and accurate record of the meeting and will be signed by the Chairman after the meeting

06 Matters arising from the previous minutes Item 14d: Sewer overflow behind the Village Hall

The Clerk reported that the issue had been resolved by Southern Water. However, although the temporary protected fencing had been removed from all areas, access to the public footpath from Newington Road was obstructed by barriers and closed signs. Clerk to contact Southern Water to see if they can be removed.

07 Presentation by Alison Thompson of English Rural

Alison introduced herself as the Deputy Development Director for English Rural Housing Association. English Rural is a specialist housing association who only develop, own and manage small homes in small villages. Alison said that in Kent they have homes in 33 small villages. They are small schemes with an average of six to eight homes. All of their homes are rented and have a proven local connection to the parish. Their tenants do not have a right to buy

The key ethos of English Rural is to provide affordable homes in small communities in perpetuity

Alison went on to say that they have been approached by the Tory Family Foundation Trust about the piece of land that they own in Peene. A planning application was recently withdrawn on the site and The Foundation have approach English Rural to buy the land if they can get support for local needs housing.

In response to the question about the layout of housing on the site, Alison stated that English Rural would not be following the previous plans but would be submitting their own planning application following discussions with the Parish Council and a community consultation.

Councillors stated that they had invested a considerable amount of time and effort over the past few years in arriving an acceptable scheme that has subsequently been withdrawn. It was stressed that any future proposals should include close consultation with both the Parish and District Councils to avoid protracted negotiations and discussions.

The Parish Council is supportive of the approached by English Rural and would like to take this matter forward. The Clerk will request that English Rural submit draft proposals and plans for the Council's considerations.

08 Open session

A parishioner noted that there is a problem with the traffic lights between the rugby club and the A20 roundabout. They are no longer vehicle activated and were working on a fixed time cycle. This results in them changing to red in the main road even when no vehicles were waiting to emerge from the channel tunnel slip road. The clerk will report this issue to Kent Highways

09 Planning

To note applications decided and pending since the meeting held on 8 March 2021 (see Appendix A to these minutes).

Application No. 21/0730/FH for 4no glamping pods and classroom along with associated paths drainage and landscaping at Beachborough Park was discussed. It was agreed to comment that, although the Council is not against the proposal, they would ask the planners be mindful of traffic arrangements where vehicles will be emerging from the site onto a busy main road.

10 Finance

- e. Council **approved** the increase in the KALC/NALC subscription for 2021/22 (from £171.26 to £172.58).

11 Highways

Concerns were raised that the street lighting in the vicinity of the bus stop on the A20 has been switched off. In view of the recent safety implications of people crossing the road from the bus stop at night, the Clerk was asked to write to Kent Highways to see if the lighting could be reinstated.

In addition, there are two street lights in Peene that are not working and will be reported.

12 Eurotunnel

Increased noise levels from the Channel Tunnel Terminal have been causing concerns in nearby houses. It is believed to be resulting from construction operations. It was agreed to review the situation at the next Parish Council meeting

13 Keep Britain Tidy – The Great British Spring clean

It was agreed to take part in the "Keep Britain Tidy – The Great British Spring Clean" which can take place between 28 May and 3 June

The Clerk will contact Councillor David Godfrey to arrange supply of the material and equipment to make this possible.

14 Any other business

- a. Reinstatement of playing field Discussions are ongoing with Sam Snart of Hobbs Parker who is acting on the Councils behalf in dealings with Balfour Beatty/Eurotunnel regarding the unacceptable reinstatement of the playing field. Sam Snart accepts it is of a poor standard and agreed that the way forward would be for him to arrange for an independent survey and costing of surface reinstatement.
 - There is also an issue with the poor quality stile erected by Balfour Beatty in the corner of the playing field, the dog gate element of which was dangerous and has been removed. Sam Snart will raise the matter with Balfour Beatty with a view to it being replaced with a kissing gate.
- b. Social Media Councillor Smith gave the meeting an update on her researches to set up a Parish Council Facebook page. She is in a position to draw up a draft policy. Councillors were unanimous in their agreement to take this matter forward and the Chairman thanked Councillor Smith for her work on this.
- c. Councillor Watt-Peters informed the meeting that due to work commitments he has decided to resign from the Parish Council and will write to the Clerk formally in due course. On behalf of his fellow Councillors the Chairman said that Councillor Watt-Peters would be missed and thanked him for his help an experience during his time in the role.
- d. Councillor Smith reported that she attended the last KALC Area Meeting and had nothing significant to report. She was happy to continue attending on behalf of the Parish Council.
